


Figure 2.1: Conceptualization of cultural assimilation




Figure 2.2: Conceptualization of multiculturalism and intercultural diversity




Figure 2.3: About the immigrant community




Figure 2.6: Outline of literature




Figure 4.2.1: Cultural Assimilation in US




Figure 4.2.2: Diversity of culture and mother tongue in India




Figure 4.2.3 Assimilated Immigrant share of US
